

Please find enclosed my completed Financial Disclosure Statement as required by Nevada Revised Statutes chapter 281A. This shall be my annual filing for calendar year 2009.

In addition to my appointed position as Winnemucca's Chief of Police, I am also a board member of the Local Emergency Planning Committee (LEPC) and their offshoot the Humboldt County Emergency Management Committee. My appointment to the LEPC originally ran from February 20, 2001 to December 31, 2004, but was renewed by the Humboldt County Commissioners in 2004.

Additionally, I have been appointed to the Nevada Public Agency Insurance Pool and Public Agency Compensation Trust Human Resources Oversight Committee (POOL/PACT HR OSC) effective July 30, 2008.

Although I do not receive compensation from either board, it is my intention to use the attached annual filing for not only my appointment as Chief of Police, but also the LEPC/HCEMC and POOL/PACT HR OSC boards.

Additionally, upon the death of my step-father, I became the Successor Trustee of the Dewey D. Huckaba Family Trust as well as the Executor/Administrator of his Last Will and Testament/Estate.
