REVIEW PANEL DETERMINATION

NRS 281A.730

The Nevada Commission on Ethics ("Commission") received Ethics Complaint No. 18-064C ("Complaint") on August 23, 2019, regarding the alleged conduct of Naomi Duerr ("Duerr"), a Councilmember for the City of Reno ("City Council"), State of Nevada, in violation of the Ethics in Government Law set forth in NRS Chapter 281A ("Ethics Law"). The Commission instructed the Executive Director to investigate alleged violations of NRS 281A.400(2) and (7).

Duerr is a public officer as defined in NRS 281A.160. The Commission has jurisdiction over this matter pursuant to NRS 281A.280 because the allegations contained in the Complaint relate to Duerr's conduct as a public officer and have associated implications under the Ethics Law. Specifically, the Complaint alleged that Duerr misused her public position to pursue services, favors and/or engagements and unwarranted preference or advantages for herself and her private campaign.

On September 18, 2019, a Review Panel ("Panel") consisting of Commissioners Brian Duffrin (Presiding Officer), Teresa Lowry, Esq. and Amanda Yen, Esq., reviewed the following: 1) Ethics Complaint No. 18-064C; 2) Order on Jurisdiction and Investigation 3) Subject's Response to the Complaint; and 4) Executive Director's Recommendation to the Review Panel with Summary of Investigatory Findings.¹

Under NAC 281A.430, the Panel unanimously finds and concludes that the facts do NOT establish sufficient credible evidence to support a determination that just and sufficient cause exists for the Commission to render an opinion in the matter regarding the allegations pertaining to NRS 281A.400(2) and (7) and 281A.520. Accordingly, these allegations are dismissed.

Nevertheless, the Panel unanimously finds and concludes that there is sufficient cause to issue a Confidential Letter of Instruction in the matter to provide education regarding the proper separation between Duerr's role as a City Councilmember and matters affecting her private campaign interests.
