REVIEW PANEL DETERMINATION

NRS 281A.730; NAC 281A.440

The Nevada Commission on Ethics ("Commission") instructed the Executive Director to investigate alleged violations of NRS 281A.420(1) and (3) regarding the conduct of Lisa Guzman ("Subject").

Subject is a public officer as defined in NRS 281A.160, and the Commission has jurisdiction over this matter pursuant to NRS 281A.280 because the allegations contained in the Complaint relate to Subject's conduct as a public officer and have associated implications under the Ethics Law.

On October 18, 2023, a Review Panel consisting of Chair Kim Wallin, CPA, CMA, CFM (Presiding Officer) and Commissioners Brian Duffrin and Barbara Gruenewald, Esq. considered the following: (1) Ethics Complaint; (2) Order on Jurisdiction and Investigation and Notice of Additional Facts and Issues; and (3) Executive Director's Recommendation to the Review Panel with Summary of Investigatory Findings and Relevant Evidentiary Exhibits.¹

Under NAC 281A.430, the Panel unanimously finds and concludes that the facts do <u>not</u> establish credible evidence to support a determination that just and sufficient cause exists for the Commission to render an opinion in the matter regarding the alleged violations of NRS 281A.420(1) and (3) and the allegations are dismissed.
