The proposed regulations will also amend various provisions of NAC Chapter 281A to streamline case management and investigatory processes related to first-party and third-party requests for opinion, including without limitation, jurisdictional reviews, motion practice before the Commission and requirements for withdrawing, reconsidering or rehearing matters.
