These minutes constitute a summary of the above proceedings of the Nevada Commission on Ethics. A recording of the meeting is available for public inspection at the Commission's office.

1. Call to Order and Roll Call.

Chair Kim Wallin, CPA, CMA, CFM appeared in-person at the State Bar of Nevada in Las Vegas and called the meeting to order at 12:00 p.m. Also appearing in-person were Vice-Chair Brian Duffrin and Commissioner James Oscarson. Present for Commission staff in Las Vegas were Executive Director Ross E. Armstrong, Esq., and Executive Assistant Kari Pedroza. Deputy Attorney General Laena St-Jules, Esq. also appeared in person in Las Vegas.

2. Public Comment.

There was no public comment.

3. Interviews and consideration of candidates for the Commission Counsel position, and possible referral to the Commission potential candidates for the Commission Counsel position. Under NRS 241.020(2)(d)(4), the Commission may consider the character and professional competence of the following candidates for the Commission Counsel position:

- 2.) Stephen Titzer
- 3.) Michael Matuska

NOTE: It is anticipated that the Subcommittee may take one or more breaks during this item to allow Staff to prepare requested documents and for other matters, at the discretion of the Chair.

Chair Wallin introduced the agenda item, outlined the interview process, and stated that the Personnel Subcommittee would be interviewing 2 applicants for the Commission Counsel position as Mr. Titzer withdrew his application following the agenda posting. She explained that upon completion of the interviews, the Subcommittee would deliberate and determine whether it would refer either or both candidates to the full Commission for final interviews.

The Personnel Subcommittee then interviewed each candidate in the following order: Oscar Peralta and Michael Matuska.

Chair Wallin expressed her gratitude to each of the applicants. Her fellow Subcommittee members echoed her comments.

The Personnel Subcommittee members discussed the merits of each candidate and the options of continuing with accepting applications for the position or referring one or both interviewees to the full Commission for final interviews.

Vice-Chair moved to table the referral of either candidate to the full Commission for final interviews and continue accepting applications for the position. Commissioner Oscarson seconded the motion and noted that the motion in no way was a reflection on the quality of or intended to be disparaging to the interviewees. The Motion was put to a vote and carried unanimously.

4. Public Comment.

There was no public comment.

5. Adjournment.

Vice-Chair Duffrin made a motion to adjourn the public meeting. Commissioner Oscarson seconded the motion. The Motion was put to a vote and carried unanimously.

I deem it a privilege to apply for the position of Ethics Commission Counsel, which I found posted on nvjobs.nv.gov. As the majority of my career as an attorney has been devoted to public service, I would welcome the opportunity to further serve the citizens of State of Nevada.

Currently, I serve as a Senior Deputy Attorney General for the State of Nevada, representing the Public Safety Division. I am responsible for providing legal advice to the Nevada Department of Corrections and defending the Department against federal civil rights actions. I took the position at this stage in my career because of my desire to return to public service, and to serve as a mentor to the younger attorneys in our department. As Senior Deputy Attorney General, I have further developed my skills as an effective manager which should serve me well as Commission Counsel.

While I have had many rewarding and challenging opportunity throughout my career, serving as an Attorney Law Clerk for both the Ninth Circuit Court of Appeals and the United States District Court was a defining point in my career. My six years working for the federal courts has provided me with extensive experience in hearing arguments and drafting opinions with findings of fact and conclusions of law. I have been repeatedly praised for my writing ability and my ability to correctly analyze complex issues, including those involving ethics.

Previously, I served as Associate General Counsel for the Sahara Las Vegas. When the Meruelo Group purchased the Sahara, they offered me the position to serve as the only attorney at the property. I functionally served as general counsel for the property by providing strategic and proactive legal advice on every issue faced by management of the new enterprise. I advised the Sahara on gaming compliance, human resource operations, proper security procedures, construction issues, and contract negotiations, just to name a few. I also served as the primary litigator for the Sahara, along with supervising outside counsel. My experience at the Sahara will be invaluable to the Ethics Commission as I was required to provide advice on how to navigate the strict and complex regulations faced by Nevada casinos, which are at least as intricate as those faced by the Ethics Commission.

I was offered the position at the Sahara because the Meruelo Group was my client when working at the firm Cohen|Johnson|Parker|Edwards. The Group was intimately familiar with my abilities as I had just prevented class certification of a multi-million-dollar wage complaint against the Grand Sierra Resort, one of the premier hotels in Reno owned by the Meruelo Group. While at Cohen Johnson, I litigated complex civil and appellate matters before Nevada and federal courts.

I also served as a Deputy City Attorney for the City of North Las Vegas. I performed many of the important functions the Ethics Commission is seeking from Commission Counsel including advising the City Council on important legal and policy issues, representing the City as a member on intergovernmental commissions, managing the City's litigation, and negotiating contracts critical to the operation of the City, with private and other government entities. My duties also included defending police officers against civil rights action, and the City in employment discrimination matters. One of my proudest accomplishments was developing a strategy for successfully arguing that the Nevada's Notice of Claim Statute was still in force despite Nevada Supreme Court precedent finding the statute to be unconstitutional. This strategy allowed the City of North Las Vegas to avoid meritless claims with minimal expense.

My commitment to public service has continued even while pursuing private practice. I have served as a member of the Functional Equivalency Committee for the Nevada State Bar. As a committee member, I take part in hearings to determine whether applicants to the Nevada State Bar, that have not graduated from ABA accredited law schools, have an education that is functionally equivalent to an ABA law school education. Part of my responsibility is to draft recommendations to the Nevada Supreme Court as to the merit of the applicants' petitions, which routinely involves ethical considerations. My unique experience should prove to be an asset to the Ethics Commission.

During my career, I have had the opportunity to associate and learn from the best. In addition to the Honorable Johnnie B. Rawlinson, I served with the Honorable Lloyd D. George, and the Honorable Kris Pickering, prior to her becoming a justice with the Nevada Supreme Court. Throughout my life and career, I have always endeavored to uphold the highest principles of ethics and integrity. I have been consistently tasked with the most difficult cases involving many of the issues that will be faced by Commission Counsel. I urge you to contact any of my previous employers, who will provide you with an accurate assessment of my legal abilities.
