REVIEW PANEL DETERMINATION

NRS 281A.730; NAC 281A.440

The Nevada Commission on Ethics ("Commission") received Ethics Complaint No. 20-023C on March 17, 2020, regarding the alleged conduct of Brett Waggoner ("Waggoner"), Director of the Planning Department, Nye County, State of Nevada. On May 4, 2020, the Commission instructed the Executive Director to investigate alleged violations of NRS 281A.400(1), (2), (5) and (7) and NRS 281A.420(1) and (3).

Waggoner is a public employee as defined in NRS 281A.150, and the Commission has jurisdiction over this matter pursuant to NRS 281A.280 because the allegations contained in the Complaint involve Waggoner's conduct as a public employee and have associated implications under the Ethics Law.

On January 19, 2022, a Review Panel ("Panel")¹ consisting of Vice-Chair Brian Duffrin (Presiding Officer) and Commissioner Barbara Gruenewald, Esq. considered the following: (1) Ethics Complaint No 20-023C (2) Order on Jurisdiction and Investigation in Ethics Complaint No. 20-023C; (3) Waggoner's Response to the Complaint; and (4) Executive Director's Recommendation to the Review Panel with Summary of Investigatory Findings.²

Under NAC 281A.430, the Review Panel unanimously finds and concludes that the facts do not establish credible evidence to support a determination that just and sufficient cause exists for the Commission to render an opinion in the matter regarding the alleged violations of NRS 281A.400(1), (2), (5) and (7) and NRS 281A.420(1) and (3).
