REVIEW PANEL DETERMINATION

The Nevada Commission on Ethics ("Commission") received this Ethics Complaint ("Complaint") on August 15, 2022 regarding the alleged conduct of Subject Oscar Delgado ("Delgado"). On September 29, 2022, the Commission instructed the Executive Director to investigate alleged violations of NRS 281A.400(2) and NRS 281A.420(1) and (3).

On November 16, 2022, a Review Panel consisting of Chair Kim Wallin, CPA, CMA, CFM (Presiding Officer) and Commissioner Thoran Towler, Esq. reviewed the following: (1) the Complaint; (2) Order on Jurisdiction and Investigation; (3) Delgado's Response to the Complaint; (4) Executive Director's Recommendation to the Review Panel with Summary of Investigatory Findings; and (5) Relevant Evidentiary Exhibits.¹

IT IS HEREBY ORDERED:

Under NAC 281A.430, the Review Panel unanimously finds and concludes that the facts do not support a determination that just and sufficient cause exists for the Commission to render an opinion in the matter regarding the alleged violations of NRS 281A.400(2) and NRS 281A.420(1) and (3). Accordingly, the Complaint is dismissed.
