**REVIEW PANEL DETERMINATION**  
NRS 281A.730; NAC 281A.440

The Nevada Commission on Ethics (“Commission”) received the above-captioned Ethics Complaints (“Complaints”) from members of the public (“Requesters”) on August 21, 2024 and August 27, 2024, respectively. The Complaints allege violations of NRS Chapter 281A by Subject Tim Logan (“Logan”). The Commission issued its Orders on Jurisdiction on October 8, 2024, which accepted jurisdiction, consolidated the Complaints, and directed the Executive Director to investigate Subject’s alleged violations of NRS 281A.400(2), NRS 281A.400(7), and NRS 281A.520.

Subject is a public officer as defined in NRS 281A.160, and the Commission has jurisdiction over this matter pursuant to NRS 281A.280 because the allegations contained in the Complaint relate to Subject’s conduct as a public officer and associate implications of the Ethics Law.

On December 17, 2024, a Review Panel consisting of Vice Chair Wallin and Commissioners Lowry, and Yen considered the following: (1) Ethics Complaints; (2) Orders on Jurisdiction; (3) Subject’s Response; and (4) Executive Director’s Recommendation to the Review Panel with Summary of Investigatory Findings and Relevant Evidentiary Exhibits.<sup>1</sup>

The Review Panel unanimously finds and concludes that although the facts do not establish credible evidence that Subject failed to comply with the requirements of NRS 281A.400(7), NRS 281A.400(2), and NRS 281A.520, and the facts and evidence do not support a determination that just and sufficient cause exists for the matter to be referred to the Commission to render an opinion.
