




## Road Trip!: Rural Training Tour


## Annual Report Highlights





In Fiscal Year 2025, the Commission accepted jurisdiction over approximately 56% and investigated about 28% of all complaints filed.

Beyond investigations, the Commission continued its practice of issuing **Letters of Instruction** and **Letters of Caution** at both the jurisdictional and review panel stages. These letters serve an important educational role—helping public officers and employees understand the law, recognize potential conflicts, and prevent future violations.



Public servants continued to ask for advice about disclosure and abstention and cooling off, but more than ever before we saw more questions on contracting and gifts/benefits.

The Commission's outreach and education team also trained more people than ever in FY 2025, a **90% increase** compared to the average of the previous 3 years!

Through individualized guidance and uptick in training, the Commission promotes ethical awareness and strengthens the integrity of public service across Nevada.

# Recent Opinions

## Formula 1 Ticket Cases

The Commission recently voted to resolve the consolidated case regarding Clark County Commissioners' acceptance of Formula 1 tickets by approving a stipulated agreement with all five County Commissioners. This stipulated agreement includes an admonishment of the County Commissioners as well as the following requirements: 1) Establishing an Ethics Officer for Clark County to oversee ethics education and compliance and 2) the County Commissioners further agree to work with Clark County to establish an event attendance policy to provide specific policies to different types of events.

The Formula 1 case highlights the importance of transparency and complying with the disclosure requirements of the Ethics Law. It is critical that public officers disclose gifts when the person who gave the gift comes before them in future matters. Resources, including decision trees on disclosure and abstention can be found in the Commission's [Ethics Manual](#) to support public servants in acting with transparency and integrity.

## Recent Dismissals Following Completion of Deferral Agreements

The three cases below were dismissed this week following the subjects completing the terms of their respective deferral agreements. Deferral agreements are designed to support public servants and their agencies in preventing future ethics violations through a combination of strategies such as education, training, policy changes, and deferral periods where further ethics violations could result in more severe penalties.
